

Cognitive Resonant Communication by Internal Speech Through Ethereal Medium at Level of Gravitational Waves

Cognitive communication requires that the parameters of its own radiation correspond to the object of influence — according to the composition of the specific fields emitted, according to their frequency characteristics, according to the modulation of radiation as a material object with some meaning (i.e., information and its coding system, algorithms for its transformations).

Promising scientific research in the field of nano and neuro technologies allows the development of nanoneurosensors with energy detector of semantic information, that increase the sensitivity of the ethereal auditory receivers for the perception of gravitational waves of internal speech of the mental field of the righteous mind

of a spiritually bright person (José Argüelles, 2011; Kuvshinov Yu. A., Kuvshinova T.I., 2013; William E. Halal., 2022; M Coleman Miller & Nicolás Yunes, 2021). With the help of holographic and spectroscopic cryptoalgorithms, the semantic information energy detector reveals the possibility of activation of internal speech by the corresponding brain neurosystems and perception of the content of incoming speech gravitational waves (Evgeny Bryndin, 2021b). K., Chartier, J. & Chang, E. F., 2019). The sensor network contains a sensor for neural decoding of speech (Rainey, S., Martin, S., Christen, A., Mégevand, P. & Fournier, E., 2020). Imaginary speech can be decoded based on low-frequency and cross-frequency characteristics of intracranial EEG (Wilson, G. H. et al., 2020).

Semantic patterns can be described by combining analytical and numerical approaches that are able to functionally set all parameters for a wide range of possible configurations. The forms of gravitational waves can be constructed by solving the equations of the gravitational field using numerical methods of relativity theory.

4. Establishing Contact of Cognitive Communication by Bioinformatic Systems

The turn has come to controlling space with the help of brain signals. Biointerfaces of several types are designed to help the wounded on the battlefield. To control drones, a virtual reality helmet "Svarog" was developed and entered service. The technology is used for remote control of all combat aircraft and armored vehicles. A device has been created that controls a combat fighter using the user's brain signals.

Biometric technologies are successfully used in law enforcement, civil registration, in the field of security of bank applications, investment, health protection and many other areas of activity.

Biometrics uses a set of automatic methods of personality recognition based on physiological or behavioral characteristics. Currently, voice recognition technology is actively developing. The use of advanced voice identification systems is the most user-friendly authentication method that provides recognition at a higher level. Voice can be transmitted via any communication network: by landline or mobile phone, by wired and wireless virtual private network, by IP networks, radio networks. Voice identification and verification technologies are used when it is necessary to confirm whether a person is the one with whom cognitive communication is established. The received voice fingerprint is compared with the voice sample in the database. Voice biometrics makes identification possible anywhere at any time.

The modern priority in the formation of cognitive communication contact is the integration of the real and virtual worlds through the technology of recording signals of brain activity (Irina Makhaeva, 2014; Sarah Wandelt, 2022). The state of the noosphere associated with the active activity of a person in the infocommunication space using biofunctional cognitive signals of a person allowed us to proceed to the implementation of a highly intelligent transdisciplinary technology for establishing contact of cognitive communication by bioinformatic systems. Bioinformatic systems carry out biocognitive control through neurocognitive information and sensory-motor biointerfaces (S.I. Rodzin & I.N. Titarenko, 2014; Evgeny Bryndin, 2021c, 2021d).

Bioinfocommunication systems include local personalized cyber-protected info modules integrated into networked global infoecosystems. The modules are adapted to remote wireless human control of surrounding and remote subjects through a cognitive bioinformatic interface. The speech bioneurointerface is designed to establish contact of cognitive communication by internal speech between subjects.

Bioinfocommunication systems with artificial intelligence of sufficient quality, safety and protection ensure stable contact of cognitive communication by internal speech between subjects.

4.1 The Quality of Artificial Intelligence Systems

The quality of artificial intelligence systems is determined by the degree of performance of the

required functionality for solving specific tasks. The quality of systems with artificial intelligence is developed during the life cycle and includes actions carried out at the stages of development, creation and operation of these systems in order to ensure the necessary level of compliance with the required functionality. Evaluation of the quality of systems with artificial intelligence determines the trust in them at the physical level by confirming the requirements for their functionality. The acceptability of quality is determined by a criterion from a set of rules and conditions. The required functionality of artificial intelligence systems is determined by the standard (Evgeniy Bryndin, 2020a). The totality of the ranked values of the characteristics and parameters of the required functionality of systems with artificial intelligence, which determine their ability to meet the intended purpose, determines the indicator of their quality. Quality indicators are determined and confirmed during the testing and operation of systems with artificial intelligence. Measures and metrics are used to quantify the quality indicator (National Standard of the Russian Federation, 2021). The values of parameters and characteristics are revealed as a result of analysis and interpretation of test results. Confirmation of the values of parameters and performance characteristics of the required functionality ensures confidence in the system with artificial intelligence.

4.2 Safety of Using Artificial Intelligence Systems

The safety of artificial intelligence systems refers to an interdisciplinary field of research related to the prevention of accidents, their misuse and various harmful consequences that they can lead to, including technical problems, risk monitoring systems and high reliability. The security of artificial intelligence systems is necessary for smart factories, health centers, cafes, services, vehicles, agriculture, defense industry, etc.

The development of a standard and criteria for the creation of systems with artificial intelligence that will be safe for humanity remains one of the urgent tasks.

The safety of the behavior of a system with artificial intelligence depends on its spatial, temporal, objective, visual and sound sensitivity within the boundaries of its use in the environment (Evgeniy Bryndin, 2020b). The

practical use of artificial intelligence systems in various spheres of society requires the introduction of safety rules and criteria.

The security of systems with artificial intelligence can be ensured by crypto encryption of conditions, situations and areas of their application to prevent harm and damage in the field of action. The security of artificial intelligence systems is provided by protocols that are created by binomial mapping, symmetric encryption, message authentication and asymmetric encryption for the formation and transmission of a message to protect against unauthorized conditions of their use. The security system has a cryptographic key. Modern encryption algorithms operate with key sizes. The probability of recognizing a key is equal to the order of the factorial of its length. Modern ciphers are divided into two categories: in-line and block. The stream cipher is a random number generator, the output of which we add modulo 2 with our cipher text.

The encryption key is the initial value of the random number generator. The author of the article participated in the development of a random number generator for the water-air system for submarines. Of all the widely used block ciphers, two can be named DES and AES. DES now has a block size of 64 bits, and a key size of 56 bits. The block size in AES is 128 bits. AES key size is 128, 192 or 256 bits. As in DES, each round of AES has its own plug-ins. All of them are generated from the encryption key for the algorithm. Manufacturers of modern processors, Intel and AMD, have developed assembly instructions for implementing AES inside the chip.

Quantum crypto encryption is the most secure way. The BB84 cryptographic protocol is a secure communication method involving quantum mechanics components. The new generation of crypto encryption is based not on mathematics, but on physics. Scientists in the field of atomic and particle physics have already entered the world of the basics of cryptography and use the laws of quantum mechanics to send messages of crypto protection that cannot be hacked.

In order to use artificial intelligence systems safely everywhere, standardization of their joint use was carried out. The standard case A.111 Application of Strong Artificial Intelligence — “ISO/IEC JTC 1/SC 42/WG 4 NO 254 TR 24030,

developed by the research center Natural informatics, helps to ensure the interface, compatibility and synergy of the safe use of intelligent systems in various sectors of the economy, industry and service (ISO/IEC JTC 1/SC 42/WG 4 Use cases and applications Convenorship: JISC (Japan), 2019). The case for the safe compatible use of artificial intelligence systems has been approved by the Japanese Technical Committee for the Standardization of Artificial Intelligence and is an international standard.

4.3 Protection of Artificial Intelligence Systems from Unauthorized Access

Methods of protection of systems with artificial intelligence from unauthorized access are applied software, hardware and technical.

Authentication and identification is performed when logging in. To perform these procedures, technical means are required, with the help of which a two-step identification and authenticity of the user's credentials is performed. It should be borne in mind that during identification, an identity is not necessarily established. It is possible to accept any other identifier set by the security service.

This is followed by authentication — the user enters a password or confirms access to the system using biometric indicators (retina, fingerprint, brush shape, etc.). In addition, authentication using USB tokens or smart cards is used. This option is weaker, since there is no complete guarantee of the safety or authenticity of such elements.

To protect the information stored in the system with artificial intelligence, multi-stage encryption and authorization tools are used. When booting the operating system, a complex password is used, which cannot be picked up by conventional methods. The possibility of a user logging in from the outside is excluded by encrypting data and using passwords to log in.

For particularly important devices, a trusted download module is used. This is a hardware controller that is installed on the computer's motherboard. It works only with trusted users and locks the device when trying to turn on in the absence of the owner.

Cryptographic methods of data encryption are also used, turning text outside the system into a meaningless set of characters.

To protect a system with artificial intelligence

from malware, it is necessary to use antivirus applications, restrict access to certain sites on the network, and firewalls should also be installed.

These measures provide protection to the system with artificial intelligence and allow you to keep it intact.

5. Natural Ether Technology of Cognitive Communication

The natural ethereal technology of cognitive communication is realized through the ethereal bodies by the internal speech of the inductor and the recipient by the concentration of mutual figurative attention. When attention is focused on the image of the human receiver, an ethereal resonant circuit appears and the connection through it of the etheric bodies of the inductor and the receiver. The impact of the activation signal on the ethereal auditory receptor of the receiver establishes the beginning of the dialogue. First of all, the device for generating and receiving gravitational waves contains a transmitter and receiver spaced apart in space, forming a communication channel, and the transmitter and receiver have identical antennas: one of them transmitting and the other receiving, while the transmitter has two chokes, a high-frequency transformer, two separation capacitors, a DC source, a high voltage source, the master generator and modulator, the receiver also has two chokes, a high-frequency transformer. The second invention of generating and receiving gravitational waves is designed to create new information channels of cellular communications, radio, television and Internet networks, including communication channels passing through conductive media such as metal screens, water and earth; for use in various industries and transport for the purpose of non-destructive testing of metals, composites and the material.
